

Amoena® “What Works For Me” Consumer Essay Contest Rules

Introduction: *Amoena USA Corporation* (“Sponsor”) is offering a “What Works For Me” Essay Contest (“Contest”). **NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

Eligibility: Entrant must be eighteen (18) years of age as of Friday, July 29, 2011, and a resident of the fifty (50) United States, its territories, or the District of Columbia. Entrant may not have won any other Amoena consumer contest within the past calendar year. Employees of Sponsor, Sponsor’s parents, subsidiaries, affiliated companies, and agents and the immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, and all those with whom such employees are domiciled, are NOT eligible.

Timing: Contest begins at 12:00:01 a.m. E.D.T. on Friday, July 29, 2011, and ends at 11:59:59 p.m. E.D.T. on Friday, September 16, 2011.

How to Enter: To enter, submit an essay of 800 words or less by emailing info@amoena.com. The writing topic is “What Works For Me?” More than one entry from any person will void ALL entries from that person. Only one (1) entry per person is allowed. You must submit all entries to the Sponsor by email or mail, with a postmark by Friday, September 16, 2011.

Drawing: This Contest will have one (1) judging and two (2) winners. A panel of judges will review all entries and choose the 2 essays that are most compelling and well-written. The entrants whose stories are selected are potential winners and must comply with all terms and conditions set forth in these official rules, and winning is contingent upon fulfilling all such requirements. For each prize, a potential winner will be selected from all entries received on or before the entry deadline. The judging will be conducted on or before Friday, September 23, 2011. If a potential winner cannot be contacted within ten (10) days after the first attempt to contact such potential winner, they will be considered to have forfeited their prize and an alternate entrant will be selected in his or her place at random from all entries received, and no obligation will be upheld by Sponsor to forfeited winner.
